[Surveyor's description of the premises follows]

Situated in the State of Ohio, Erie County, Vermilion Township, City of Vermilion, and being located in original Lot 7 of Section 1, and also being in parcel number 18-01013.000 known as Lot 427 in the Valley View Estates Subdivision Number 19, recorded in Plat Record Volume 19, Page 8 as described in a deed to as described in a deed to Michael B. Aten and M. Christine Aten of record in Deed Volume 477, Page 118; all references being to the Recorder's Office, Erie County, Ohio, and being more particularly described as follows:

Being a parcel of land lying on the RIGHT side of the centerline of right of way of Pineview Drive, being referenced to said centerline of right of way, unless otherwise noted, as shown on the ODOT right of way plan SRTS-VERMILION PHASE 2.

Beginning, for reference, in a point being 25.00 feet RIGHT of station 306+20.24 of the centerline of right of way of Pineview Drive, said point being the northwest corner of said Lot 427 in the southerly right of way line of Pineview Drive; thence in the existing southerly right of way line and the northerly line of said Lot 427, North 89° 52' 08" East, 52.42 feet to a point 25.00 feet RIGHT OF STATION 306+72.65 of the centerline of right of way of Pineview Drive, said point being the **TRUE POINT OF BEGINNING** for the parcel herein described; thence the following four (4) courses:

1. Continuing in the existing southerly right of way line of Pineview Drive and the northerly line of said Lot 427, **North 89° 52' 08" East, 20.08 feet** to a point being **25.00 feet RIGHT** of station **306+92.73** of the centerline of right of way of Pineview Drive; thence
2. Leaving the existing southerly right of way line of Pineview Drive and the northerly line of said Lot 427, **South 00° 00' 00" West, 13.00 feet** to a point being **38.00 feet RIGHT** of station **306+92.70** of the centerline of right of way of Pineview Drive; thence
3. **South 89° 52' 08" West, 20.08 feet** to a point being **38.00 feet RIGHT** of station **306+72.62** of the centerline of right of way of Pineview Drive; thence

4. North 00° 00' 00" East, 13.00 feet to **THE TRUE POINT OF BEGINNING**, containing **0.0060** acres of land.
